## VETERANS AFFAIRS & REHABILITATION REPORT and VETERAN SERVICE OFFICER REPORT

Two items to present:

- 1. (Under Veterans Affairs & Rehabilitation) VA's partnership with National Cancer Institute will boost veteran access to clinical trials. The VA is working with cancer institute folks at 12 different regions (in our area it is Bronx, NYC) to allow veterans to enroll in cutting-edge clinical trials. The purpose is to test experimental treatments that assist in the treatment of cancer therapies. This is strictly a voluntary program and is designed to assist veterans in cancer prevention and symptom management.
- 2. (Under Veteran Service Officer) The Delaware County Veterans transportation service to Albany. Currently we provide free transportation to our area veterans daily. This service has been in effective for approximately 50 years. To utilize the service, veterans need to call our office at least 24 hours prior to their scheduled appointment, giving us their name, phone number to be reached in case of problems with the run, appointment time (s), and which pick-up point will be utilized (Walton 5:30, Delhi 6:00, Bloomville 6:15, Hobart 6:25, Stamford 6:30, and Grand Gorge 6:49). Riders should be at the pick-up point 15 minutes prior to departure to prevent missing the ride.

If the riders have to cancel they can call and advise us at the office. If it's during a time when we are unable to get to the phone (on another line, after hours, weekends) just leave a message on the bus message stating that you are canceling your ride and try to make it at least 24 hours prior to the date of your appointment.

This has been an extremely well received service since the veteran does not have to drive (in any of the Delaware County weather conditions) and can readily make their appointments. It needs to be understood that the VA has NO involvement in transportation. We receive no funds from the VA and do this service because of veteran's needs.

To that end, ridership has dropped slightly. To keep this service and justify its existence we need veterans to use the bus/van. The main drawbacks for most folks is getting up early and having to wait for the last appointment of the day. The fact we must get to Albany by 8:00 – 8:30 determines that need. Once there, we need to make sure all come back (if possible). If ridership goes down too much, we may have to cancel this service (justification for a full time driver/or even part time), which we don't want to do. Please advise your posts to use it if at all possible.
